Concurrent Systems Incorporated Limited END USER LICENSE AGREEMENT

1. PERMITTED USE

Concurrent Systems Inc. Ltd. ("CSI" OR "Licensor") grants Licensee a network-floating, single-user, non-transferable, non-exclusive, worldwide, fully paid-up right to use the enclosed CSI software product and its documentation, solely in executable format, for Licensee's own internal business purpose on a single computer network. The Licensee may physically transfer the software from one computer network to another provided that any copies of the software are removed from the network from which the software is being transferred.

2. RESTRICTIONS ON USE

The Licensee MAY NOT:

- (a) copy the software or documentation except to make one copy of the software for backup purposes
- (b) transfer, sublicense, rent, distribute, or grant Licensee's rights in the software or the documentation, or in this End User License Agreement, to others
- (c) modify, disassemble, reverse assemble, or create derivative works based on the software

3. OWNERSHIP

CSI retains title of the software, the documentation and all copies thereof. CSI is protected by United Kingdom copyright laws, international treaty provisions, and all other applicable national laws.

4. TERMINATION

The Licensee may terminate this Agreement at any time on notice to CSI. CSI may terminate this Agreement if Licensee fails to comply with any of its terms. A written notification will be sent to the Licensee, giving 10 days to correct the non-compliance. CSI's right of termination is in addition and without prejudice to any other rights and remedies available to CSI. Upon termination, the Licensee's right to use the software and documentation shall terminate and the Licensee shall return or destroy all copies of the software and documentation, at CSI's option.



5. SUPPORT

An annual support contract can be purchased through CSI, details of support services and associated costs covered by this contract are provided in the 'Software Support Agreement' document which can be supplied on request.

6. WARRANTY

CSI represents and warrants to Licensee that its software, if properly installed and operated on a computer for which it is designed, will perform substantially in accordance with the specifications set forth in the manual provided with the software (the "Limited Warranty"). CSI further represents and warrants that the software will not infringe any intellectual property right of any third party, and that all reasonable endeavours have been undertaken to ensure the software will not include any harmful or malicious code. The Limited Warranty period commences on the date of delivery to Licensee and is good for ninety (90) days thereafter. Any implied warranties covering the software, including any warranties of merchantability of fitness for a particular purpose, are limited in duration to ninety (90) days from the date of delivery.

7. LIMITATION OF LIABILITY

EXCEPT AS PROVIDED HEREIN, IN NO EVENT SHALL EITHER PARTY BE LIABLE TO THE OTHER PARTY FOR ANY INDIRECT, SPECIAL OR CONSEQUENTIAL DAMAGES OR LOST PROFITS, ARISING OUT OF OR RELATED TO THIS LICENSE AGREEMENT, EVEN IF THE LICENSOR HAS BEEN ADVISED OF THE POSSIBILITY THEREOF OR FOR ANY CLAIM BY ANY OTHER PARTY. EACH PARTY'S LIABILITY TO THE OTHER PARTY HEREUNDER, IF ANY, SHALL IN NO EVENT EXCEED THE TOTAL OF THE LICENSE FEES PAID TO LICENSOR HEREUNDER BY THE LICENSEE. IN NO EVENT SHALL LICENSOR BE LIABLE TO LICENSEE FOR ANY DAMAGES RESULTING FROM OR RELATED TO ANY FAILURE OF THE SOFTWARE PRODUCTS, INCLUDING, BUT NOT LIMITED TO LOSS OF DATA, OR DELAY OF THE LICENSOR IN THE DELIVERY OF THE LICENSED PRODUCT OR IN THE PERFORMANCE OF SERVICES UNDER THIS LICENSE AGREEMENT OR RELATED AGREEMENTS.

8. INDEMNITY CLAUSE

CSI will not hold the Licensee responsible if CSI violates any registered patents or copyright laws.

10. GOVERNING LAW AND JURISDICTION

This License Agreement and warranty are governed by English Law.

11. CONFIDENTIALITY; NO PUBLICITY

Neither party shall disclose the existence or contents of this Agreement, except

(a) to enforce rights hereunder in court

(b) to agents as necessary to perform obligations, provided such agents owe a duty of confidentiality or are subject to an agreement containing covenants of confidentiality at least as restrictive as those contained herein

(c) as required by law

Neither party may use the other party's name, likeness, trademark, service mark, logo, nor other identifying information, except as provided herein. CSI shall not include Licensee in customer lists, or otherwise imply their endorsement or relationship, in any form whether orally, online or in print, except with prior written authorization from Licensee for a specific referral instance, which authorisation may be withheld or revoked at any time at Licensee's sole discretion.
